Food Rescue Program - In 2020 Hole Food Rescue (HFR) recovered just under 163,000 pounds of food from local restaurants and grocers. This is equivalent to almost 136,000 meals that were distributed back to the community. HFR is supported by a team of 110 volunteers that rescue food seven days a week, 365 days a year. In 2020, HFR rescued 9,000 pounds of food from local restaurants that had to shut down operations suddenly due to the pandemic.

Food Recipient Program - HFR expanded their No-Cost Grocery Program (NCGP) model in order to bring food directly to those most affected by the pandemic in 2020. Through the NCGPs, HFR distributed free, rescued food to approximately 190 families each week. Locations included: Teton Free Clinic, Blair and Timber Apartments, & Senior Center of JH. HFR also expanded their Sprout program, in an effort to eradicate childhood hunger in Teton County. HFR provided 6,340 free lunches to children throughout the summer in local neighborhoods and parks.
